Position: Custodial Support, Part-Time

Job Location: 17150 Waterloo, Grosse Pointe MI, 48230

Schedule: Approx. 25-30 hours per week. Monday -Friday evenings approximately 9 pm-3 am; weekends as needed (facility closed on major holidays)

Compensation: Up to \$20 per hour (premium shifts), plus access to facility amenities

The Neighborhood Club is a non-profit servicing the Grosse Pointe communities (service population of approximately 50,000) for more than 100 years. The Neighborhood Club operates a Recreation and Wellness Center that opened in January 2013. The 48,051 square foot facility has a fitness center, fitness studio, gymnasium, indoor pool, locker rooms, preschool, multi-purpose community room, rowing/fitness room, Sports Enhancement Center, and two training/conference rooms. Beaumont Health System is a long-term tenant in the facility occupying approximately 25% of the building space providing adult physical therapy and services for children with special needs.

Responsibilities of position

- General cleaning and maintenance of the Neighborhood Club Recreation and Wellness facility.
- Clean indoor pool including scrub pool floor and walls while in water, operate pool vacuum, clean windows, and pool deck.
- Clean floors – tile, wood, rubber, and carpet.
- Operate floor cleaning machines in areas as listed above.
- Deep clean all areas of the building as assigned – chair rails, base moldings, lights, etc...
- Perform basic cleaning skills throughout the facility on a regular basis.
- Follow through on a detailed cleaning schedule for daily, weekly, monthly, and annually.
- Follow through on any preventive maintenance as scheduled for daily, weekly, monthly, and annually.
- Responsible for enforcement of state and local laws pertaining to cleaning, maintenance, and code requirements.
- Perform other miscellaneous duties and responsibilities as determined by Facility Operations Supervisor or designee.

Qualifications and Requirements

- Previous facility cleaning experience is preferred.
- Ability to react to emergency situations and provide building support as needed.
- Ability to work effectively with the public and staff in a courteous and tactful manner.
- Ability to work without or under limited supervision.
- Ability to lift 45 lbs regularly, able to bend and reach, climb ladders, and enjoy physical work.
- Ability to follow direction and instructions as provided by Supervisors.
- Must pass a background check as conducted by Neighborhood Club staff.
