## Rules and Expectations of Hosts and Guests

To make this a special experience for you, your guests and staff, please observe with the following guidelines:

- Please arrive no more than 20 minutes before your party's start time to make any final touches to the room and to greet guests. You have 20-minutes after the party's end-time to clean up.
- Decorations may not be hung on the walls, but you may use suction cups and hang decorations on the windows.
- Party times cannot be extended.
- Include Members of the facility in your total number of guests. The room holds approximately 20 people seated, with a room capacity of 30.
- Please direct all questions to the Party Coordinator during the event. If your Coordinator is not present, please ask the front desk to page them over the intercom.
- Please, no catering companies or food trucks as space is limited. You are responsible for accommodating for allergies of guests and ensuring your food is properly prepared for consumption. The Neighborhood Club is not responsible for any food-borne illness or allergic reactions. Party hosts are fully liable for the health of their guests.
- Alcohol is not allowed in the Neighborhood Club. Those who are suspected of drinking will be asked to leave the facility.
- Review the Pool Rules and Aquatic Age Guidelines

*Please understand that accidents do happen in the pool and the Neighborhood Club will do everything in its power to make your party enjoyable should you not be able to use the swimming facility.*

### POOL RULES

- Parental supervision is required.
- For party guests 3-8 years of age, they must have parental supervision IN the water. If parents will not be in the water, they must wear a Coast Guard Approved lifejacket, stay in the zero depth and 3ft sections, or pass the swim test.
- Non-potty trained children must wear a swim diaper and please make sure all children use the restroom before entering the water. If any children are wearing a diaper, please check it often and immediately remove child if they have a bowel movement in the diaper.
- Guests who are ill, have open sores, rashes, or an infectious condition are not permitted in the pool.
- Party guests will share the pool during Family Swim.
- Please do not bring glass containers, food or beverages on the pool deck.
- No outside toys are permitted in the pool. We provide noodles, beach balls and have a splash area for children.
- Please review all pool rules before using the facility. Rules will be enforced by the lifeguards for the safety of our guests and members. Some rules include: no running, no diving, no roughhousing, no shoes on deck, no slapping noodles on the water and please do not go into the lap lanes.
- Children are welcome to use the entire pool with the exception of the 5 foot area, marked by a floating buoy. For children to go past this point, they must be at least 5 feet tall or pass the Neighborhood Club Swim Test (jumping into the 5 foot end of the pool, surfacing and swimming a length to the other end of the pool).

### AQUATIC AGE GUIDELINES

Age 14 and Older: full, unsupervised use after completing a scheduled orientation, along with a signed parent consent form (available in the Fitness Center)

Age 9-13 (During Family Swim) Child may swim without a Parent/Supervisor\* present. To enter the 5' section of the pool, children must pass a Neighborhood Club swim test, or wear a Coast Guard approved life jacket.

Age 3-8 (During Family Swim) Parent/Supervisor\* must remain in the pool area at all times AND: in the water directly supervising the child, unless the child is wearing a Coast Guard approved life jacket, or has passed a Neighborhood Club swim test.

Age 0-2: Parent/Supervisor must be in the water directly supervising the child.
